Description of appointment Types:

Centred Care Initial appointments are up to 30 minutes and for one treatment area only.

Extended Care Intial appointments are for complex or multiple treatment areas and are up to 45 minutes.

Ready Care appointments are our shortest available appointment, and they are used for a very breif check or taping. They are no longer than 10 minutes in length.

Focused Care appointments are from 10 to 20 minutes in length and for one treatment area only. They are used for simple treatments and for dry needling consults.

Centred Care appointments are our standard appointment length, unless prior arrangments are made. They are for all appointments up to 30 minutes and for one treatment area only.

Extended Care appointments are 30 to 45 minutes and are for complex or multiple treatment areas.

Advanced Care appointments are only available with either Laura or Shelley, and are reserved for the more complex treatments, Women's Health, hand injuries and lymphoedema.

Terms of treatment: Cancellations must be made with at least 24 hours notice prior to your appointment otherwise a non-attendance fee will apply. We ask for all non compensable accounts to be settled on the day of treatment and we have provided HICAPS and EFTPOS for your convenience.
